## Mark Scheme

This booklet contains the mark scheme for the English Unit 2: The Writer's Craft Higher Tier Question Paper.

The questions on this paper have been designed to enable candidates to show what they can achieve in relation to a detailed study of a text. The specification aims to encourage students to:

- i respond to texts critically, sensitively and in detail, selecting appropriate ways to convey their response, using textual evidence as appropriate;
- ii explore relationships and comparisons between texts, selecting and evaluating relevant material.

Examiners should allow the candidate to determine their own approach, and assess what the candidate has offered, rather than judging it against predetermined ideas of what an answer should contain.

Examiners must assure themselves that, before they score through passages they consider to be completely irrelevant, they have made every effort to appreciate the candidate's approach to the question.

A crossed-out response should be marked if there is no other response on the paper.

### Assessment Objectives

These could include the following points:</b></p> <ul style="list-style-type: none"> <li>• Sam has tacit approval from many in the crowd: 'unspoken support'</li> <li>• Meena thinks he has changed for the worse: the 'soft shadows' which suggested a milder side to him have gone</li> <li>• the 'blonde bullet' simile suggests aggression/destruction</li> <li>• the metaphor 'crowd erupted' indicates the extent of the furore he has created</li> <li>• the crowd are divided: 'shuttit!', 'he's got a point'</li> <li>• the onomatopoeic 'babble' hints at the crowd's confusion</li> <li>• the metaphor 'cut through' stresses Alan's desire to answer Sam</li> <li>• violent verbs ('grabbed', 'threw him off') describe the behaviour between Ince and Alan</li> <li>• the adjective 'fierce' describing the exchange between Pembridge and Ince also suggests violence</li> <li>• the crowd is described as a single entity: 'collective intake of breath'</li> <li>• the people become spectators at a gladiatorial or sporting encounter: 'arena', 'epic'.</li> </ul> <p><b>Accept any other valid response.</b></p>
